

## **CKC SAFE SPORT POLICY MANUAL MEMBER DECLARATION**

### **MEMBER IMPLEMENTATION OF CKC SAFE SPORT POLICY MANUAL**

The undersigned Member hereby formally adopts and agrees to implement CKC's Safe Sport Policy Manual, as adopted by the CKC Board of Directors on February 5, 2020 (and in force as of March 1, 2020), and as amended from time to time, and further declares as follows:

- That it will implement CKC's Safe Sport Policy Manual within the scope of its authority, notably within its business, activities, and events, which includes, but is not limited to, competitions, practices, evaluations (including time controls or any other form of testing), training camps, travel, the club or office environment, and any meetings held on or off the Member's premises;
- That it will require that, as a condition of membership or as a condition of being involved with the Member in any capacity, that all registered members, Board and committee members, participants and any other person falling under its authority will agree to be bound by all of the policies found in the CKC Safe Sport Policy Manual, as well as any other relevant and applicable CKC policies;
- That it will respect the authority of any relevant and applicable decision-maker identified in the CKC Safe Sport Policy Manual, and that it will ensure that all of its registered members, Board and committee members, participants and any other person falling under its authority explicitly agrees to the same;
- That it will report the outcomes of any decisions made under its authority pursuant to the policies found in the CKC Safe Sport Policy Manual to CKC within seven (7) days of the decision being rendered;
- That it will cooperate with investigations conducted by CKC or any investigators with authority to act in such a function pursuant to the CKC Safe Sport Policy Manual or any other relevant and applicable policy(ies) and that it will ensure that, as a condition of membership, all of its registered members, Board and committee members, participants and any other person falling under its authority explicitly agree to the same;
- That it will ensure that all of its registered members, Board and committee members, participants and any other person falling under its authority are aware of the existence of the CKC Safe Sport Policy Manual and, where feasible, to provide them with reasonable levels of education regarding the contents and processes found in the Manual;
- That, subject to applicable law, it will not knowingly employ a person in any position, or include any person on a Board or Committee or in any other capacity, if that person has been provisionally suspended or is serving a suspension under the CKC Safe Sport Policy Manual or the rules of any other sport organization with authority over that person;
- That it will implement and enforce any provisional suspension decision or other decision rendered by a decision-maker with authority to make such a decision under the CKC Safe Sport Policy Manual or under the rules of any other sport organization with authority to do so;
- That, if relevant, it will withhold some or all funding or support to any person who has been found to be in breach of the CKC Safe Sport Policy Manual or the rules of any other sport organization that has authority over that person;

- That it will vigorously pursue all potential breaches of the CKC Safe Sport Policy Manual that fall within its authority;
- That it will cooperate with and assist any other Member investigating or pursuing a potential breach of the CKC Safe Sport Policy Manual; and
- That it will take appropriate action to discourage non-compliance with the CKC Safe Sport Policy Manual.

The undersigned Member agrees to be bound by the present declaration and is responsible for the implementation and the enforcement of these provisions.
