



# **AMENDMENT TO PART 2, SECTION 4 & 5 OF THE CKC-SRD TOKYO 2020 OLYMPIC TEAM CRITERIA SUPPLEMENT**

Draft, March 8, 2021

## **1. Summary**

Canoe Kayak Canada was informed by COPAC on March 3, 2021 that due to the evolution and current status of the coronavirus pandemic in Curitiba, Brazil that the Continental Olympic Qualifier which was previously scheduled for April 8-11, 2021 has been cancelled. As such, the Olympic Qualification System of the International Canoe Federation, Section D3.3.4 will allocate the available Continental quotas on the basis of results obtained at the *2019 Canoe Sprint Senior World Championships*.

This amendment to the CKC-SRD internal nomination procedures is intended to address this exceptional circumstance as is permitted by Section G of the CKC-SRD Tokyo 2020 Olympic Team Criteria Supplement (INP). As such, CKC-SRD is proposing an amendment to Part 4 of the INP as follows:

## **2. Existing Criteria**

### **4. NOMINATION BASED ON CONTINENTAL QUALIFICATION - *CONTINENTAL OLYMPIC QUALIFIER***

#### **4.1 General**

*The Continental Olympic Qualifier* is the second opportunity for CKC-SRD to qualify athlete quota positions for the Tokyo 2020 Olympic Games. Please refer to the *Olympic Qualification System of the International Canoe Federation* which describes the procedures and criteria that Crews must achieve in order to earn a quota position for the Tokyo 2020 Olympic Games.

4.1.1 There are several key elements of this qualification criteria that impacts on CKC-SRD's ability to nominate athletes to compete at the *Continental Olympic Qualifier*. They are as follows:

4.1.1.1 Only K1/C1 and K2/C2 Olympic events are on the *Continental Olympic Qualifier* program.

4.1.1.2 CKC-SRD is eligible to compete in all events on the *Continental Olympic Qualifier* Program with the exception of Women C1 200m

- 4.1.1.3 Boats and athletes that have previously qualified or earned an athlete quota cannot compete.
- 4.1.1.4 The maximum number of athlete quotas a NOC can earn through the *Continental Olympic Qualifier* in the K1/C1 events is (1) for each discipline.
- 4.1.1.5 The maximum number of athlete quotas a NOC can earn through the *Continental Olympic Qualifier* overall per discipline is (2).
- 4.1.2 CKC-SRD will be guided by the following principles in making its nominations to the COC for inclusion on the Tokyo 2020 Olympic Team based on results at the *Continental Olympic Qualifier*:
  - 4.1.2.1 The crew or crews that demonstrate the greatest potential to earn CKC-SRD athlete quotas will be nominated to compete at the *Continental Olympic Qualifier*.
  - 4.1.2.2 CKC-SRD will accept the maximum number of quotas allocated to the CKC-SRD at the *Continental Olympic Qualifier* subject to Sections 4.1.1.2, 4.2 and 4.3 below.
  - 4.1.2.3 Notwithstanding the aforementioned, CKC-SRD may return a quota or quotas where the entries for Canada do not permit the crew to start in an event at the Tokyo 2020 Olympic Games as required by the ICF Qualification System (B.4.2).
  - 4.1.2.4 The final selection of boats and quotas by the CKC-SRD may require the athletes nominated to start in another distance or event at the Games as required by the ICF Qualification System.
  - 4.1.2.5 CKC -SRD is limited to 2 (two) quotas per discipline at the *Continental Olympic Qualifier* regardless of the number of events CKC-SRD may win. Where the number of crews that satisfy the ICF Qualification criteria to earn the NOC athlete quotas at the *Continental Olympic Qualifier* exceeds 2 (two), CKC-SRD must make a decision between one or more crews to determine the actual nomination of athletes to the COC for inclusion on the Tokyo 2020 Olympic Team. Under these circumstances, WC#1 will be used as the *Performance Assessment* to determine nominations to the COC for inclusion on the Tokyo 2020 Olympic Team.
  - 4.1.2.6 It may be that the crew(s) who win at OTT are ineligible to compete at the *Continental Olympic Qualifier* as stipulated by the ICF Qualification System (B.4.2). In such circumstances, CKC will determine the crew that will compete at the *Continental Olympic Qualifier* according to the criteria listed in Section 4.2 below.
  - 4.1.2.7 It may be that athletes that race at the *Continental Olympic Qualifier* and qualify the boat will not be nominated to the COC for inclusion on the 2020 Tokyo Olympic Team. This could be due to the requirement for a *Performance Assessment* where CKC-SRD qualifies more than the maximum of eligible quotas, or an athlete or crew is unable to be nominated as all events and athletes for the events have already been determined based on results at OTT.

4.1.2.8 Athletes who are selected to the *Continental Olympic Qualifier* but are not nominated to the COC for inclusion on the Tokyo 2020 Olympic Team will, as applicable, be nominated to:

4.1.2.8.1 2021 Senior World Cup Team

AND

4.1.2.8.2 2021 Junior World Team

OR

4.1.2.8.3 2021 Senior World Cup Team

AND

4.1.2.8.4 2021 U23 World Team

4.1.2.9 Athletes who are selected to the *Continental Olympic Qualifier* but are not nominated to the COC for inclusion on the Tokyo 2020 Olympic Team will be considered for an AAP nomination. Note: athletes nominated for AAP support will nevertheless be subject to standard progression criteria where applicable.

#### 4.2 Nomination process for crews that are **not** eligible to compete at the *Continental Olympic Qualifier*

4.2.1 Where a crew that is **not eligible** to compete at the *Continental Olympic Qualifier* wins Final 1 and Final 2 at OTT or where required a race-off, this crew will be conditionally nominated to the COC for inclusion on the Tokyo 2020 Olympic Team subject to the following:

4.2.2.1 CKC-SRD qualifying the event

4.2.2.2 Where CKC-SRD exceeds the max quotas, a *Performance Assessment* at WC#1 is required.

4.2.2.3 If a *Performance Assessment* is required, the crew or crews that demonstrate the greatest potential to reach the A Final at the Tokyo 2020 Olympic Games will be nominated. Please see section 4.4. for details

4.2.2.4 The **eligible crew** with the *highest position of finish* in Final 1 and Final 2 at OTT, or, where required, the winner of a race-off, will be nominated to compete at the *Continental Olympic Qualifier* to qualify the boat for CKC-SRD

OR

The CTO/HC and the NDC may determine at the conclusion of Final 2 or a Race-off, that another crew combined of a non-qualified athlete from the conditionally nominated crew and another non-qualified athlete will compete at the *Continental Olympic Qualifier*. In this scenario there will be an additional race-off. Included in the race-off will be the new crew and the eligible crews with the highest position of finish in Final 1 and Final 2.

#### 4.3 Nomination process for crews that **are** eligible to compete at the *Continental Olympic Qualifier*

4.3.1 If a crew that is **eligible** to compete at the *Continental Olympic Qualifier* wins Final 1 and Final 2 (or, where required, wins a race-off), this crew will be

conditionally nominated to the COC for inclusion on the 2020 Tokyo Olympic Team subject to the following:

- 4.3.1.1 CKC-SRD qualifying the event
- 4.3.1.2 CKC-SRD exceeds the max quotas, a *Performance Assessment* at WC#1 is required.
- 4.3.1.3 If a *Performance Assessment* is required, the crew or crews that demonstrate the greatest potential to reach the A Final at the Tokyo 2020 Olympic Games will be nominated. Please see section 4.4 for details.

#### 4.4 Nomination process based on Performance Assessment at WC#1

##### 4.4.1 Kayak Scenarios

- 4.4.1.1 This scenario applies to both Men and Women Kayak. Where CKC-SRD wins the Men K1 1000 & 200 and / or Women K1 500 & 200 *at the Continental Olympic Qualifier* with different athletes but does not win Men K2 1000 or Women K2 500:
  - 4.4.1.1.1 CKC-SRD will conduct a *Performance Assessment* to select the crew with the greatest potential to be in the A Final at the Tokyo 2020 Olympic Games.
  - 4.4.1.1.2 The *Performance Assessment* will be based on results at WC#1.
  - 4.4.1.1.3 Note: CKC-SRD will be required to start in the Men K1 1000 or Women K1 500 at the Tokyo 2020 Olympic Games.
- 4.4.1.2 This scenario applies to both Men and Women Kayak where CKC-SRD wins one or both of the Men K1 1000/ Men K1 200 and / or Women K1 200 / 500 and also wins the Men K2 1000 and / or Women K2 500 at the *Continental Olympic Qualifier*:
  - 4.4.1.2.1 CKC-SRD will conduct a *Performance Assessment* to select the crew or crews with the greatest potential to be in the A Final at the Tokyo 2020 Olympic Games.
  - 4.4.1.2.2 The *Performance Assessment* will be based on results at WC#1.
  - 4.4.1.2.3 If the Men K2 1000 and / or the Women K2 500 is determined to have the best overall performance at WC#1 they will be nominated to the Tokyo 2020 Olympic Team.
  - 4.4.1.2.4 If the Men K1 1000 and the Men K1 200 are ranked first and second on the *Performance Assessment* of results at WC#1, they will be nominated to the Olympic Team, but must also start in the K2 event at the Tokyo 2020 Olympic Games. Similarly, if the Women K1 500 and the Women K1 200 are ranked first and second on the *Performance Assessment* of results at WC#1, they will be nominated to the Olympic Team, but must also start in the K2 event at the Tokyo 2020 Olympic Games.
  - 4.4.1.2.5 If the Men K2 1000 and / or the Women K2 500 crew is ranked second based on the *Performance Assessment* of

results obtained at WC#1 but the K1 crew that achieves the highest position of finish at WC#1 is also a member of the Men K2 1000 and / or Women K2 500 crew, then the K1 crew and the K2 crew will be nominated to the Olympic Team.

**NOTE:** In the scenario described immediately above, if the K1 crew is not in the K2 crew, then CKC-SRD will exceed the maximum quotas for the Tokyo 2020 Olympic Games. The second quota will be allocated based on a *Performance Assessment* of results at WC#1. Involved in this assessment will be the 2<sup>nd</sup> ranked K1 athlete at OTT and a K2 crew composed of the nominated K1 athlete and an athlete to be determined by the CTO in consultation with the NDC. CKC-SRD must start in the K2 event in this scenario.

#### 4.4.2 Canoe Scenarios

- 4.4.2.1 This scenario applies to both Men and Women Canoe where CKC-SRD wins Men C1 1000 and / or Women C1 200 but does not win Men C2 1000 and / or Women C2 500 *at the Continental Olympic Qualifier*. The Men C1 1000 and / or the Women C1 200 will be nominated.
- 4.4.2.2 This scenario applies to both Men and Women Canoe where CKC-SRD wins Men C2 1000 and / or Women C2 500 but does not win Men C1 1000 and / or Women C1 200 *at the Continental Olympic Qualifier*. The Men C2 1000 and / or the Women C2 500 will be nominated.
- 4.4.2.3 This scenario applies to both the Men and Women Canoe where CKC-SRD wins the Men C1 1000 and / or the Women C1 200 and Men C2 1000 and / or the Women C2 500 *at the Continental Olympic Qualifier*.
  - 4.4.2.3.1 CKC-SRD will conduct a *Performance Assessment* to select the crew with the greatest potential to be in the A Final at the Tokyo 2020 Olympic Games.
  - 4.4.2.3.2 The *Performance Assessment* will be based on results at WC#1.
  - 4.4.2.3.3 If the C1 crew that achieves the highest position of finish is also a member of the C2 crew, then the C1 crew and the C2 crew will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
  - 4.4.2.3.4 If the C1 crew is not in the C2 crew then CKC-SRD will exceed the maximum quotas.
    - 4.4.2.3.4.1 If the C2 crew is determined to have the best overall performance at WC#1 they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
    - 4.4.2.3.4.2 If the C1 crew is determined to have the best overall performance at WC#1 they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. The second quota will be allocated based on a *Performance*

*Assessment* of results at WC#1. Involved in this assessment will be the 2<sup>nd</sup> ranked C1 athlete at OTT and a C2 crew composed of the nominated C1 athlete and an athlete to be determined by the CTO in consultation with the NDC. Should the 2<sup>nd</sup> ranked C1 athlete also be the athlete determined to be the best C2 option there is no need for a *Performance Assessment* and both athletes will be nominated. CKC-SRD must start in the C2 event in this scenario.

### 3. Amendment

CKC-SRD proposes the following amendment to Section 4:

#### 4. NOMINATION BASED ON 2019 CANOE SPRINT WORLD CHAMPIONSHIPS CONTINENTAL QUOTA ALLOCATION

##### 4.1 General

Due to the coronavirus pandemic, the *Continental Olympic Qualifier* has been cancelled, therefore quotas available to National Olympic Committees at this competition will be awarded according to results obtained at the 2019 Canoe Sprint World Championships. Please refer to Section D3.3.4 of the *Olympic Qualification System of the International Canoe Federation*.

4.1.1 Based on the 2019 Canoe Sprint Senior World Championships, Canada will be allocated the following Continental Quotas:

Men's Kayak	2
Women's Kayak	1
Women's Canoe	0*
Men's Canoe	2

\* CKC-SRD will request additional quotas from the ICF and IOC citing exceptional circumstances. This process has already been initiated.

4.1.2 CKC-SRD will apply the following principles in making its nominations to the COC for inclusion on the Tokyo 2020 Olympic Team based on *Continental Olympic Qualification*:

4.1.2.1 All crews that achieve two wins at OTT will be provided the opportunity to earn a nomination based on a *Performance Assessment* at WC#1 unless it is cancelled (please see Section 4.1.2.8 below for the process that will apply in such circumstances).

4.1.2.2 CKC-SRD will accept the maximum number of quotas allocated to the CKC-SRD based on the *Continental Olympic Qualification* subject to Sections 4.1.2.3 below.

- 4.1.2.3 Notwithstanding the aforementioned, CKC-SRD may return a quota or quotas where the entries for Canada do not permit a crew to start in an event at the Tokyo 2020 Olympic Games as required by the ICF Qualification System (B.4.2).
- 4.1.2.4 The final selection of boats and quotas by the CKC-SRD may require the athletes nominated to start in another distance or event at the Games as required by the ICF Qualification System.
- 4.1.2.5 It may be that, if athletes achieve two wins at OTT in multiple events, CKC may be required to consider second place athletes in those events for a *Performance Assessment*. This will only be required where CKC-SRD has available quotas and events for these crews to compete.
- 4.1.2.6 Athletes who are selected to compete at World Cup #1 but are not nominated to the COC for inclusion on the Tokyo 2020 Olympic Team will, as applicable, be nominated to:
  - 4.1.2.8.2 2021 Junior World Team
  - OR
  - 4.1.2.8.4 2021 U23 World Team
- 4.1.2.7 Athletes who are selected to *World Cup #1* in Continental Qualification events but are not nominated to the COC for inclusion on the Tokyo 2020 Olympic Team will be nominated for AAP support. Note: athletes nominated for AAP support will nevertheless be subject to standard progression criteria where applicable.

## 4.2 Nomination process based on Performance Assessment

### 4.2.1 Men's Kayak (maximum of 6 quotas)

- 4.2.1.1 The Men's Kayak discipline will be allocated two additional quotas based on the Continental Qualification assignment of quotas from the *2019 Canoe Sprint Senior World Championships*.
- 4.2.1.2 The *Performance Assessment* in Men's Kayak will not take place until the conclusion of the Men's K4 500 selection process.
- 4.2.1.3 If the crew that achieves two wins in the Men's K2 1000 at OTT is determined after *WC#1 Performance Assessment* to have a greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the crews that achieved two wins in the Men's K1 1000 and the Men's K1 200 at OTT, then the Men's K2 1000 will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. In such circumstances, the men's kayak Continental Qualification selection process will be complete.
- 4.2.1.4 If either crew or both crews that achieves two wins in Men K1 1000 or Men K1 200 crews at OTT are determined after the *WC#1 Performance Assessment* to have the greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the Men's K2 1000 crew that achieved two wins at OTT, then the crew or crews that achieved two wins in the Men K1 1000 and the Men K1 200 at OTT will be nominated to the COC for inclusion on

the Tokyo 2020 Olympic Team. In such circumstances, the men's kayak Continental Qualification selection process will be complete.

4.2.1.5 If, following WC#1 and OTT, and after the K4 selection process is complete, there are no more than six different athletes in the K1 1000, K1 200, K2 1000 and K4 500 events, then all crews will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.

4.2.1.6 If, following WC#1 and OTT, and after the K4 selection process is complete, fewer than six athletes are included in the K1 1000, K1 200, K2 1000 and K4 events, then the allocation of the remaining quotas will be allocated according to the following process:

4.2.1.6.1 If there is one quota remaining, and there is an entry for this quota at the Olympic Games, the K1 1000, K1 200 or K2 1000 (containing one athlete from the K4) with *highest rank* at OTT will be nominated or where there is a tie, the relevant crews will be nominated to WC#1. The crew that is determined after a *Performance Assessment* at WC#1 to have the greatest chance of making the A Final at the Olympic Games will be nominated. In such circumstances, the men's kayak Continental Qualification selection process will be complete.

4.2.1.6.2 If there are 2 athlete quotas remaining, and there is an entry for those quotas at the Olympic Games, the K1 1000, K1 200 and/or K2 1000 with *highest rank* at OTT will be nominated or where there is a tie, the relevant crews will be nominated to WC#1. The crew(s) that is determined after a *Performance Assessment* at WC#1 to have the greatest chance of making the A Final at the Olympic Games will be nominated as follows:

If the Men's K2 1000 (both athletes are not in the K4) is determined after the WC#1 *Performance Assessment* to have the greatest potential to reach the A Final at the Tokyo 2020 Olympic Games, then the Men K2 1000 will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team but not the Men's K1 1000 or the Men's K1 200. In such circumstances, the men's kayak Continental Qualification selection process will be complete.

If either the Men K1 1000 and Men K1 200 or the Men K2 1000 (containing one athlete in the K4) and one of either the Men K1 1000 or K1 200 is determined after the WC#1 *Performance Assessment* to have the greatest potential to reach the A Final at the Tokyo 2020, then they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.

4.2.1.7 Note: In all the scenarios above, Canada must start in the K2 1000 event.

#### **4.2.2 Women's Kayak (maximum of 5 quotas)**

4.2.2.1 The Women's Kayak discipline will be allocated one additional quota based on the Continental Qualification assignment of quotas from the *2019 Canoe Sprint Senior World Championships*.

- 4.2.2.2 Any *Performance Assessment* required in the Women's Kayak discipline will not take place until the conclusion of the Last Chance Global Qualifier at World Cup #2 where the Women's Kayak discipline may earn an additional quota. (See section 5 for information on the allocation of additional quotas based on the Last Chance Global Qualifier)
- 4.2.2.3 If the crew that achieves two wins at OTT in the Women's K2 500 contains an athlete who was not nominated based on K4 selection at OTT and is determined after the *Performance Assessment* to have a greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the winners of the Women's K1 500 or the Women's K1 200 at OTT the Women's K2 500 will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team . In such circumstances, the Women's kayak Continental Qualification selection process will be complete.
- 4.2.2.4 If the crew that achieves two wins at OTT in the Women's K1 500 or Women's K1 200 crew at OTT are determined after the *Performance Assessment* to have a greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the winner of the other K1 or the Women's K2 500 crew that won at OTT, then they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team . In such circumstances, the Women's kayak Continental Qualification selection process will be complete.
- 4.2.2.5 If, following WC#1 and OTT, and after the Last Chance Global Qualifier selection process is complete, there are no more than five different athletes in the K1 500, K1 200, K2 500 and K4 500 events, then all crews will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. In such circumstances, the women's kayak Olympic selection process will be complete.
- 4.2.2.6 If, following WC#1 and OTT, and after the Last Chance Global Qualifier selection process is complete, fewer than five athletes are included in the K1 500, K1 200, K2 500 and K4 500 events then the allocation of the remaining quotas will be allocated according to the following process:
- 4.2.2.6.1 If there is one quota remaining, and there is an entry for this quota at the Olympic Games then the K1 500, K1 200 or K2 500 with *highest rank* at OTT will be nominated or where there is a tie, the relevant crews will be nominated to WC#1. The crew that is determined after a *Performance Assessment* at WC#1 to have the greatest chance of making the A Final at the Olympic Games will be nominated unless the K2 is composed of two athletes that are not in the K4. The only way the K2 in this instance can be considered for a *Performance Assessment* is if one athlete in the crew is also in the K4 or Canada earns an additional quota at the Last Chance Global Qualifier.
- 4.2.2.7 Note: In all the scenarios above, Canada must start in the K1 500 event.
- 4.2.2.8 Any additional quotas must be earned through the **GLOBAL OLYMPIC QUALIFIER – ICF 2021 CANOE SPRINT WORLD CUP 2**. For details, please see the Amendment below as it relates to Section 5 of the CKC-SRD Tokyo 2020 Olympic Games Team Selection Criteria Supplement.

#### 4.2.3 Men's Canoe (maximum of 2 quotas)

- 4.2.3.1 The Men's Canoe discipline will be allocated two quotas based on the Continental Qualification assignment of quotas from the *2019 Canoe Sprint Senior World Championships*.
- 4.2.3.2 Any *Performance Assessment* required in the Men's Canoe discipline will not take place until the conclusion of the Last Chance Global Qualifier at World Cup #2, where the Men's Canoe discipline may earn an additional quota.
- 4.2.3.4 If the crew that achieves two wins at OTT in the Men's C1 1000 is also in the crew that achieves two wins in Men's C2 1000 at OTT then both athletes will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
- 4.2.3.5 If the crew that achieves two wins at OTT in the Men's C1 1000 is not part of the crew that achieves two wins in the Men's C2 1000 at OTT, then both crews will be nominated to WC#1. The crew that is determined after the *Performance Assessment* to have the greatest potential to reach the A Final at the Tokyo 2020 Olympic Games will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
  - 4.2.3.5.1 If Canada earns a quota at the **GLOBAL OLYMPIC QUALIFIER – ICF 2021 CANOE SPRINT WORLD CUP 2**, then the crew that achieves two wins in C1 1000 and C2 1000 at OTT will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
  - 4.2.3.5.2 If, after WC#2, Canada does not earn an additional quota and the C2 1000 crew is determined after the *Performance Assessment* to have the greatest potential to reach the A Final at the Tokyo 2020 Olympic Games, it will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
  - 4.2.3.5.3 If, after WC#2, Canada does not earn an additional quota and the C1 1000 crew is determined after the *Performance Assessment* to have the greatest potential to reach the A Final at the Tokyo 2020 Olympic Games, they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. The C1 1000 crew with the *highest rank* at OTT will also be nominated and not the C2 1000 crew.
- 4.2.3.6 Note: In all the scenarios above, Canada must start in the C2 1000 event
- 4.2.3.7 Any additional quotas must be earned through the **GLOBAL OLYMPIC QUALIFIER – ICF 2021 CANOE SPRINT WORLD CUP 2**. For details, please see the Amendment below as it relates to Section 5 of the CKC-SRD Tokyo 2020 Olympic Games Team Selection Criteria Supplement.

#### 4.2.4 Women's Canoe (maximum of 1 quota)

- 4.2.4.1 The Women's Canoe discipline will be not be allocated a quota based on the Continental Qualification assignment of quotas from the 2019 Canoe Sprint Senior World Championships.

- 4.2.4.2 CKC-SRD has made a request to the ICF and the IOC for additional Continental quotas citing exceptional circumstances.
- 4.2.4.3 If Women's Canoe is awarded one additional quota by the ICF and the IOC, then Women's Canoe will have a total of 2 quotas and the following process will apply:
  - 4.2.4.3.1 If the crew that achieves two wins in the Women C1 200 at OTT is also in the winning Women's C2 500 crew at OTT, then both crews will be nominated.
  - 4.2.4.3.2 If the crew that achieves two wins in the Women's C1 200 at OTT is not part of the crew that achieves two wins in the Women's C2 500, then the crew that is determined to have achieved the *highest rank* in the Women C1 200 at OTT will also be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team but not the C2 500.
- 4.2.4.4 If Women's Canoe is not awarded an additional quota, then Continental Qualification does not apply. Please refer to Global Qualification criteria (Part 2, section 3)
- 4.2.4.5 If Women's Canoe is awarded two additional quotas then the following process will apply:
  - 4.2.4.5.1 If the crew that achieves two wins in the Women's C1 200 at OTT is not in the crew that achieves two wins in the Women's C2 500 at OTT, then both crews will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
  - 4.2.4.5.2 If the crew that achieves two wins in the Women's C1 200 at OTT is part of the crew that achieves two wins in the Women's C2 500 crew from OTT, then the crew that has achieved the *highest rank* in the Women C1 200 at OTT will also be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.

## 4. Existing Criteria

### 5. NOMINATION BASED ON ATHLETE QUOTAS ACHIEVED AT THE *GLOBAL OLYMPIC QUALIFIER – ICF 2021 CANOE SPRINT WORLD CUP 2*

- 5.1 The *Global Olympic Qualifier – ICF 2021 Canoe Sprint World Cup 2* is the last opportunity for CKC-SRD to qualify athlete quota positions for the Tokyo 2020 Olympic Games.  
Please refer to *Olympic Qualification System of the International Canoe Federation* which describes the procedures and criteria that Crews must achieve in order to earn a quota position for the Tokyo 2020 Olympic Games.

- 5.2 If CKC-SRD does not achieve an athlete quota in the K1/C1 event(s) at the *Continental Olympic Qualifier* and CKC-SRD does not exceed the maximum quotas for the discipline,

then CKC-SRD will identify crews to compete at the *Global Olympic Qualifier – ICF 2021 Canoe Sprint World Cup #2* subject to the following criteria:

1.. A crew that competes at the *Continental Olympic Qualifier* and does not achieve Olympic Qualification will be nominated to the *Global Qualifier – 2021 Canoe Sprint World Cup #2* in order to compete for an athlete quota in a K1 or C1 event.

Or

2.. Where CKC-SRD wins the K2 or C2 event at the *Continental Olympic Qualifier* and an athlete from the K2 or C2 crew also competes in the K1 or C1, then the eligible crew with the *highest rank* in the K1 or C1 event at OTT will be nominated to the *Global Qualifier – 2021 Canoe Sprint World Cup #2*.

5.3 If the Canadian crew achieves the *highest position of finish* amongst all eligible NOC's in the respective K1/C1 events at the *Global Qualifier – 2021 Canoe Sprint World Cup #2*, they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.

## 5. Amendment

### 5. NOMINATION BASED ON ATHLETE QUOTAS ACHIEVED AT THE *GLOBAL OLYMPIC QUALIFIER – ICF 2021 CANOE SPRINT WORLD CUP 2*

5.1 The *Global Olympic Qualifier – ICF 2021 Canoe Sprint World Cup 2* is the last opportunity for CKC-SRD to qualify athlete quota positions for the Tokyo 2020 Olympic Games.

Please refer to *Olympic Qualification System of the International Canoe Federation* which describes the procedures and criteria that Crews must achieve in order to earn a quota position for the Tokyo 2020 Olympic Games.

5.2 In those events where CKC-SRD can still achieve an athlete quota in the K1/C1 event(s) and CKC-SRD does not exceed the maximum quotas for the discipline, then CKC-SRD will identify crews to compete at the *Global Olympic Qualifier – ICF 2021 Canoe Sprint World Cup #2* subject to the following criteria:

5.2.1 CKC-SRD will be eligible to compete for an additional quota in the following events:

5.2.1.1 Women's K1 200m

5.2.1.2 Men's C1 1000m

5.2.2 The eligible crew that achieves the *highest rank* at OTT in one of the events above will be nominated to the *Global Qualifier – 2021 Canoe Sprint World Cup #2* in order to compete for an athlete quota in a K1 or C1 event.

5.3 If the Canadian crew achieves the *highest position of finish* amongst all eligible NOC's in the respective K1/C1 events at the *Global Qualifier – 2021 Canoe Sprint World Cup #2*, then Canada will have earned an additional quota and the following process will apply:

### 5.3.1 Women's Kayak

- 5.3.1.1 Women's Kayak discipline will have achieved six quotas
- 5.3.1.2 If the crew that achieves two wins in the Women's K2 500 at OTT (both athletes are not part of the K4) and it is determined after the WC#2 *Performance Assessment* to have a greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the crews that achieved two wins in the Women's K1 500 or the Women's K1 200 at OTT, the Women's K2 500 will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. In such circumstances, the Women's kayak Olympic selection process will be complete, and the steps below will not apply.
- 5.3.1.3 If one of the crews that achieves two wins at OTT in the Women's K1 500 (not part of the K4) or Women's K1 200 (not part of the K4) are determined after the WC#2 *Performance Assessment* to have a greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the Women's K2 500 that achieved two wins at OTT, then both the Women's K1 500 and the Women's K1 200 at OTT will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. In such circumstances, the women's kayak Olympic selection process will be complete, and the steps below will not apply.
- 5.3.1.4 If the crew that achieved two wins in K2 500 at OTT (contains only one athlete from the K4) and the crew that achieved two wins in the K1 200 (not in the K4) at OTT are both determined after the WC#2 *Performance Assessment* to have a greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the Women's K1 500 (not in the K4) that achieved two wins at OTT, they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. In such circumstances, the women's kayak Olympic selection process will be complete, and the steps below will not apply.
- 5.3.1.5 If the crew that achieved two wins in K2 500 at OTT (contains only one athlete from the K4) and the crew that achieved two wins in the K1 500 (not in the K4) at OTT are both determined after the WC#2 *Performance Assessment* to have a greater potential to reach the A Final at the Tokyo 2020 Olympic Games than the Women's K1 200 (not in the K4) that achieved two wins at OTT, they will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. In such circumstances, the women's kayak Olympic selection process will be complete, and the steps below will not apply.
- 5.3.1.6 If, after OTT, WC#1 and WC#2, there are no more than six different athletes who have won the K1 500, K1 200, K2 500 and K4 events at OTT, then all crews will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.
- 5.3.1.7 If, after OTT, WC#1 and WC#2, five athletes are included in the crews that achieve two wins in the K1 500, K1 200, K2 500 and K4 500 events from OTT then the remaining quota will be allocated according to the following process:
  - 5.3.1.7.1 If, after OTT, WC#1 and WC#2, there is one athlete quota remaining, and there is an entry for this quota at the Olympic

Games, then the crew with the *highest rank* in the relevant distance in the K1 500 (not in the K4) or K1 200 (not in the K4) or K2 500 (containing only one K4 athlete) at OTT will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. Where there is a tie at OTT, the relevant crews will be nominated to WC#1. The crew that is determined after a *Performance Assessment* at WC#1 to have the greatest chance of making the A Final at the Olympic Games will be nominated.

5.3.1.6 Note: In all the scenarios above, Canada must start in the K1 500 event.

5.3.1.7 In the event that WC#2 is cancelled, quotas will be allocated according to the results of the 2019 Canoe Sprint Senior World Championships. In this scenario, Canada will not earn an additional quota in the Women's K1 200m.

### **5.3.2 Men's Canoe**

5.3.2.1 Men's Canoe discipline will have achieved three quotas

5.3.1.2 If the crew that achieves two wins in the Men's C2 1000 at OTT is different from the crew that achieves two wins in the Men's C1 1000, then both crews will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team. The Men's Canoe Olympic selection process will be complete, and the steps below will not apply

5.3.2.3 If the crew that achieves two wins in the Men's C11000 is also in the Men's C2 1000 that achieves two wins at OTT, then the crew that finishes 2<sup>nd</sup> in the Men's C1 1000 at OTT will be nominated to the COC for inclusion on the Tokyo 2020 Olympic Team.

5.3.2.4 In the event the WC#2 is cancelled, quotas will be allocated according to the results of the 2019 Canoe Sprint Senior World Championships. In this scenario, Canada will not earn an additional quota in the Men's C1 1000m.
